RESOLUTION No 011

The International Treasury Monetary One, as a Global Regulator, the Owner of all Global and Historical financial assets, proclaims the CONE of CREATION (DIVINE CREATION LAWS) binding on all subjects of Law in the World. All financial and economic activities of all subjects of Law in the World must be carried out in accordance with legal international norms within the CONE of CREATION (DIVINE CREATION LAWS).

We remind that the International Treasury Monetary One is the owner and manager of the World Global Account of the International Treasury Monetary One No. **01-00-01-4-AAA-777-C3-AM-01**, which was located in the **WORLD BANK** until October 29, 2021, and distributed to various banks in countries around the world.

We remind that the International Treasury Monetary One is the owner and manager World Global Account of the International Treasury Monetary One No. **01-1-700-3516 222 777 8888 999**, which was located in the **WORLD BANK** until October 29, 2021, and distributed to various banks in countries around the world.

We remind that the International Treasury Monetary One is the owner and manager of assets, including accounts under the names: “White Spiritual Boy”, “Spiritual Wonder Boy”, “Spiritual Wonder Brothers”, “Morning Star”, “King David”, “Prophet Muhammad”, “Demas and Saint Timothy”, “White Mongolia”, “White Vatican”, “White Eagle”, “Maria Sinukuan or Divine Crystal”, “Maria Divine Banahaw or Sunflower”, “Maria Cristina or Divine Magdalene”, “Maria Makiling or Divine Ester Egg”, “Falcon”, “Alpha – Omega” and other accounts located in different Banks in 189 (One hundred eighty-nine) countries around the World.

It is noted that the International Treasury Monetary One, by virtue of its universal nature and legitimacy, is a unique and key Organization for finding effective solutions in international economic issues to influence the development process in the world, and we reaffirm that the International Treasury Monetary One is well-positioned to participate in various reform processes aimed at improving and strengthening the effective functioning of the international financial system and architecture, while recognizing that the International Treasury Monetary One and international financial institutions are endowed with complementary capabilities, as a result of which the coordination of their actions is crucial.

We remind that over the past period of more than two years everyone who tried to challenge our legal right to own and dispose of Global financial assets, made sure that all the Rights to own, manage and dispose of Global Financial Assets were transferred to the International Treasury Monetary One represented by His Majesty Alexander Nikolaevich Paramonov in compliance with all the rules of Law and laws of Our World, and also were

able to verify the sacred basis of Divine Law as an indisputable fact, witnessing the miracles of the Great Divine Providence,

In order to implement the World Program to Overcome the Global Financial Crisis and prevent the Third World War (the Resolution No. 1 dated 07.04.2020), taking into account the violations of International norms of Law, Sovereign Rights, the Rule of Law, Resolutions, Declarations, Conventions, Treaties of the United Nations, for non-fulfillment of their commitments towards the Owner of the Global Financial System, committed by the well-known name of financiers Rothschild, the International Treasury Monetary One makes the following decisions:

We revoke all rights of accounting, disposal and control over World Accounts and assets (including accounts under the names:

“White Spiritual Boy”, “Spiritual Wonder Boy”, “Spiritual Wonder Brothers”, “Morning Star”, “King David”, “Prophet Muhammad”, “Demas and Saint Timothy”, “White Mongolia”, “White Vatican”, “White Eagle”, “Maria Sinukuan or Divine Crystal”, “Maria Banahaw or Divine Sunflower”, “Maria Cristina or Divine Magdalene”, “Maria Makiling or Divine Ester Egg”, “Falcon”, “Alpha – Omega” and ither accounts) from public, private-public structures and all related private organizations: Rothschild & Sons (The United Kingdom of Great Britain), Banque Privee Edmond de Rothschild (Switzerland), Rothschild Concordia, Rothschild & Co and others.

We recall all assets that had been previously transferred under the management and disposal of well-known financiers of the Rothschild family name, placed in central banks, national and/or state banks, commercial banks and funds (any financial and other organizations), in all countries around the world.

Due to the huge number of financial and stock crimes of well-known financiers of the Rothschild family name around the World, and especially financial, stock, and other crimes against a Sovereign Country, the Union of Soviet Socialist Republics, and the Sovereign Soviet People, the International Treasury Monetary One as the World Financial Regulator imposes a BAN on the activities with well-known financiers of the Rothschild family name in the World Financial and Stock Systems in any form. Furthermore, all subjects of Law, such as sovereigns, individuals, legal entities, state organizations, and private-state structures shall be instructed to terminate any financial and economic relations with well-known financiers of the Rothschild family name.

We activate the blocking of the access to all system codes as for accounting, distribution and control that the Rothschild family name group and all subjects of law affiliated with them, such as organizations, banks, companies and others.

In connection with the transfer of assets to the full ownership, disposal and management of the International Treasury Monetary One, observing all the norms of International Law, the assets have been entered into the balance sheet of the International Treasury Monetary One. In this regard, we order the immediate blocking of all assets directly or indirectly under the control and management of well-known financiers of the Rothschild family name.

In the case that some legal entities go ahead with any financial and economic relations with the members of the Rothschild family name, such legal entities and their affiliated structures shall be annexed.

From the moment of receipt (in any way and in any form) of this notification we instruct financial and control organizations, law enforcement organizations to make the

necessary system notifications in the Global Financial System within 48 (forty-eight) hours, in order to timely notify all financial, banking, interbank, control and law enforcement organizations.

In connection with the withdrawal of assets, in order to maintain the functioning and financing of programs, only one option is possible for the formation of a future financial system – which is the activation of cooperation with the International Treasury Monetary One with a view to obtaining programs and instructions for conducting further financial activities.

We remind that any unauthorized actions with the International Treasury Monetary One using the above assets for the purpose of monetization in the financial system shall constitute a crime and are the corporate and personal (individual) responsibility of persons, officials and bank officers who commit these crimes.

We remind that the Sacred Rights of the Custodians of the above assets have been revoked, and any actions contrary to the Resolution of the International Treasury Monetary One No. 4 (004/RES2021) dated February 23, 2021. “The cancellation of historical assets in order to form a new well-balanced financial system” shall have immediate (inescapable) sacred and obvious consequences for the Custodians with manifestation in the material world,

We remind that in order to prevent fraud and deception of bona fide subjects of Law, it is prescribed to transfer the register of documents for entry into the liquidation memorandum for the purpose of accounting, analysis, and evaluation of the integrity of Ex-custodians, Ex-holders, and Ex-managers of the right to manage historical assets of the Global Financial System,

The International Treasury Monetary One decides to continue to deal with these issues through its specialized unit - the Special Department for Overcoming the Global Financial Crisis “Anti-Crisis Center”.
