We hereby confirm that the *International Treasury Monetary One* is the owner and manager of the World Global Account of the *International Treasury Monetary One* No. **01-00-01-4-AAA-777-C3-AM-01**, which was located in the **WORLD BANK** until October 29, 2021, and distributed to various banks in countries around the world.

We remind that the *International Treasury Monetary One* is the owner and manager World Global Account of the *International Treasury Monetary One* No. **01-1-700-3516 222 777 8888 999**, which was located in the **WORLD BANK** until October 29, 2021, and distributed to various banks in countries around the world.

We remind that the *International Treasury Monetary One* is the owner and manager of assets, including accounts under the names: “White Spiritual Boy”, “Spiritual Wonder Boy”, “Spiritual Wonder Brothers”, “Morning Star”, “King David”, “Prophet Muhammad”, “Demas and Saint Timothy”, “White Mongolia”, “White Vatican”, “White Eagle”, “Maria Sinukuan or Divine Crystal”, “Maria Divine Banahaw or Sunflower”, “Maria Cristina or Divine Magdalene”, “Maria Makiling or Divine Ester Egg”, “Falcon”, “Alpha – Omega” and other accounts located in different Banks in 189 (One hundred eighty-nine) countries around the World.

We are *guided* by previous resolutions and statements of the *International Treasury Monetary One*;

We hereby confirm that the Military People's Council of the USSR is the Successor of the Legislative, Judicial and Executive Power of the Union of Soviet Socialist Republics (Resolution of the First Congress of Citizens of the USSR №1 dated December 30, 1991, Mandate of Trust of the First Congress of Citizens of the USSR № 1/1 dated December 30, 1991 , Resolution of the First Congress of Citizens of the USSR to the United Nations and to the International Community of All Countries of the World № 1/2 dated December 30, 1991, Resolution of the First Congress of Citizens of the USSR № 1/3 dated December 30, 1991, eight hundred and seventy-four delegates including from the Republics of the USSR participated in the First Congress of Citizens of the USSR: from the RSFSR three hundred and sixty-eight delegates, from the Ukrainian SSR one hundred and eighty-six delegates, from the Byelorussian SSR ninety-four delegates, from the Kazakh SSR fifty-four delegates, from the Armenian SSR thirty-one delegates, from the Moldavian SSR thirty delegates, from the Uzbek SSR twenty-four delegates, from the Tajik SSR sixteen delegates, from the Kirghiz SSR fourteen delegates, from the Azerbaijan SSR twelve delegates, from the Latvian SSR ten delegates, from the Georgian SSR nine delegates, the Turkmen SSR eight delegates, from the Estonian SSR six delegates. Of the delegates who were present at the First Congress of Citizens of the USSR the following worked and voted unanimously: three hundred and eighty-six Deputies of the Supreme Soviet of the USSR;

two hundred and sixty-four Deputies of the Supreme Soviets of the Union Republics of the USSR; one hundred and forty-nine deputies of regional, city and district formations; fifty-seven Deputies of settlement and rural Soviets of the USSR, seven Delegates from power structures of the USSR).

We hereby confirm that according to the Resolution of the Presidium of the Military People's Council of the USSR: State Decree of the USSR № 81-6 dated October 07, 2018 about the restoration of the activities of the Treasury of the Union of Soviet Socialist Republics, the International Treasury Monetary One performs the function of the Treasury of the Union of Soviet Socialist Republics. The post of Treasurer of the Union of Soviet Socialist Republics has been entrusted to the Secretary General and Chief Treasurer of the International Treasury Monetary One, His Majesty Alexander Nikolaevich Paramonov.

We hereby confirm that according to the Resolution of the Presidium of the Military People's Council of the USSR №11/11/11 dated October 18, 2013 and the Order of the Presidium of the Military People's Council of the USSR №11 dated October 25, 2013, the Fund of social and economic development of regions "Treasury of the Creator of RA", headed by the Director, His Majesty Alexander Nikolayevich Paramonov, was approved in the Status of the Supreme Organizational and Executive State Body of the Union of Soviet Socialist Republics in the monetary, financial, socio-economic and cultural spheres of the Union of Soviet Socialist Republics.

We reaffirm that the decision of the Congress of People's Deputies of the Union of Soviet Socialist Republics of March 14, 1990 No. 1360-I (Law of the Union of Soviet Socialist Republics of March 14, 1990 No. 1360-I "On the establishment of the post of President of the Union of Soviet Socialist Republics and excluded Articles No. 6 «On the Leadership Role of the Central Committee of the Communist Party» from the Constitution of the Union of Soviet Socialist Republics, Amendments and Additions to the Constitution (Basic Law) of the Union of Soviet Socialist Republics") is illegitimate and illegal as the Congress of People's Deputies The Union of Soviet Socialist Republics was first opened in May 25, 1989 in the city of Moscow and is the Highest legislative Organ of the Union of Soviet Socialist Republics, but within the framework of the Constitution of the Union of Soviet Socialist Republics of October 07, 1977, without the right to make amendments and additions to the Constitution of the Union of Soviet Socialist Republics of October 07, 1977.

On the basis of Exclusive Historical Law, the Right of the Sovereign, by the Right of the Owner of All World Assets from the Creator of the New Era and by the Right of the Main Regulator of the World Financial System, We confirm that on the basis of the Right of the Sovereign of the Union of Soviet Socialist Republics, on the basis of International Law, the Sovereign Country of the Union of Soviet Socialist

Republics is the Sovereign and acting Subject of International Law together with Sovereign Citizens Of The Union Of Soviet Socialist Republics,

We hereby inform that during the investigation with the help of the State Security Committee of the Union of Soviet Socialist Republics, as well as International Law Enforcement and Counter-Terrorism Organizations, only in one of the many episodes it became clear that in the 1980s and 1990s criminal officials of the highest leadership level of the Union of Soviet Socialist Republics and the Secretary General of the Central Committee of the Communist Party of the Soviet Union Gorbachev M.S., and later, the illegitimate President Mikhail Gorbachev, together with the President of the Russian Soviet Federative Socialist Republic Yeltsin Boris (suspended for illegal actions from the post of President of Russia (CONSTITUTIONAL COURT OF the RUSSIAN FEDERATION CONCLUSION No. Z-2 of September 21, 1993), acting on a criminal plan to rob a Sovereign Country, Sovereign People, Sovereign Citizens of the Union Of the Soviet Socialist Republics, organized embezzlement and theft of assets of the Union of Soviet Socialist Republics. The stolen assets from the Sovereign were transferred in various criminal ways to the various organizations and individual person.

We affirm that this crime is absolutely unacceptable and violates the most serious articles in the field of criminal law of a Sovereign Country of the Union of Soviet Socialist Republics, subjects and sub-subjects of the Law of the Union of Soviet Socialist Republics, and in the field of International Criminal Law.

In order to restore Justice, according to the Exclusive Historical Right, the Right of the Sovereign, the Right of the Owner of All World Assets from the Creator of the New Era and the Right of the Chief Regulator of the World Financial System, all the above Decrees, Resolutions and Notifications are confirmed, the Decree of the Presidium of the Military People's Council of the USSR №4444 dated October 29, 2015 is confirmed.

On the Basis of the foregoing, we decide:

To deprive of Legal Personality and Outlaw all subjects of the Law of those who are guilty of this crime.

To declare, confirm and declare illegal the Belovezhsky agreement, declared on December 08, 1991 by Yeltsin B.N., Kravchuk L.M., Shushkevich S.S.

To revoke All Rights to own, manage, store and dispose of All financial and valuable assets of the Sovereign country of the Union of Soviet Socialist Republics and the Sovereign Soviet People from financial and banking officer Viktor Vladimirovich Gerashchenko, from all authorized and unauthorized custodians, holders, managers and illegal owners.

According to the Exclusive Historical Right, the Right of the Sovereign, on the basis of the Right of the Owner of All World Assets from the Creator of the New Era and on the basis of the Right of the Chief Regulator of the World Financial System, we confirm that on the basis of the Right of the Sovereign of the Union of Soviet Socialist Republics, on the basis of International Law, Resolutions of the Military People's Council USSR: Decree of the Presidium of the Military People's Council of the USSR № 11/11/11 dated October 18, 2013; Decree of the Presidium of the Military People's Council of the USSR №4444 dated October 29, 2015; Decree of the Presidium of the Military People's Council of the USSR GP USSR №81-6 dated October 07, 2018, On the restoration of the activities of the Treasury of the Union of Soviet Socialist Republics, the right of ownership, management, disposal and storage of all valuable and financial assets of the USSR and the profit received on the basis of these assets, has the State Treasury of the Union of Soviet Socialist Republics, represented by the International Treasury Monetary One, headed by the Secretary General and Chief Treasurer of the International Treasury Monetary One, His Majesty Alexander Nikolaevich Paramonov.

All Law Enforcement and Counter-Terrorist Country and International Organizations, Country and International Financial and Banking Control Organizations, all officers and employees of the Country and International Financial and Banking Systems immediately have to monitor, audit, block, arrest and confiscate with transfer to the International Treasury Monetary One in order to be credited to The balance sheet of the Treasury of the Union of Soviet Socialist Republics of all Bank and non-bank accounts, all financial and valuable assets and the profit earned on their basis.

With regard to former authorized and unauthorized custodians, holders, managers, illegal owners and all subjects of law, it is necessary to conduct an investigation and prosecute a criminal punishment to the fullest extent of the Law of the Sovereign Country of the Union of Soviet Socialist Republics, subjects and sub-subjects of the Law of the Union of Soviet Socialist Republics and International Criminal Law.

I leave control over the execution of this resolution to the Security Department of the International Treasury Monetary One and the Department of International Affairs of the International Treasury Monetary One.
