### We hereby Decide:

- 1) Confiscated from the criminal sect of the Illuminati and their satellites, servants and accomplices the Right to own, control, record, dispose and manage a trademark Banknote of Russia (Russian ruble) with primary registration in London (as well as possible registration in the state company Russian Federation - Russia ), which is used as a means of payment (having the sign of the ruble) by the State Company Russian Federation - Russia and a foreign company (Central Bank of the Russian Federation "Bank of Russia"), registered with the State Company Russian Federation - Russia on the Sovereign Territory of the Great Sovereign Country - the Union of Soviet Socialist Republics, in particular in the Russian Soviet Federative Socialist Republic - Russia, **Transfer** the Right to own, control, record, dispose and manage the Sovereign Country - the Union of Soviet Socialist Republics, represented by the State Bank of the USSR.
- 2) This Order also performs the function of the Sovereign unilateral Transfer of the Right to own, control, record, dispose and manage the Banknote of Russia (Russian ruble) with primary registration in London (as well as possible registration in the state company Russian Federation - Russia), which is used as a means of payment (having the sign of the ruble) by the State Company Russian Federation - Russia and a foreign company (the Central Bank of the Russian Federation "Bank Russia"), registered in the State Company Russian Federation - Russia on the Sovereign Territory of the Great Sovereign Country - the Union of Soviet Socialist Republics, in particular in the Russian Soviet Federative Socialist Republic - Russia.
- 3) All Subjects of the Right on the Sovereign Territory of the Great Sovereign Country - the Union of Soviet Socialist Republics and on the territory of the entire World to show Respect and unquestioningly comply with all Legal Acts of the new Owner of the Rights to own, control, record, dispose and manage the Banknote of Russia (Russian ruble) with initial
